## PLEASE READ!!!

1. Fill out the application completely and print legibly.
  - A. SELECT the number of 8’ tables for either SALE or DISPLAY. The cost of the first table is \$120, which includes membership to the GBPA. Each additional table is \$100. **REMINDER:** If you want an endcap, you must reserve at least 3 tables. We reserve the right to refuse additional tables.
  - B. Be sure you have (or will get) a PA sales tax number. Do not wait for the tax number to return your application.
  - C. PRINT your name, address, phone number and e-mail address.
  - D. Fill out the “I will sell/display the following” section as best as you can. This section may be a determining factor in approving table applications. Vague descriptions or leaving this section empty may lessen your chances at receiving a sale table.
  - E. Names for badges: Print the two names you want to have on your badges.
  - F. SIGN YOUR APPLICATION! Your signed application acknowledges receipt and acceptance of the rules and regulations of the show including, for 2020, the COVID regulations as described in the Show Information.
2. Table assignments: All sale tables will be located in one room.
3. Special requests will be considered, but not guaranteed!
4. The show committee reserves the right to refuse a table to anyone for any reason.
5. Table confirmations will be sent out as soon as is practical.
6. Early admission VIP passes will be available for \$100 from 2 PM to 7 PM on Friday, Sept. 25<sup>th</sup>, 2020, as well as dealer entry time on both Saturday and Sunday.

7. Sept. 15th, 2020 is the deadline date for returning applications in order to assure your current participation in the show.

## **Rules and Regulations**

**\*SEE COVID-19 RULES AS DESCRIBED IN THE INFORMATION EMAIL\***

1. No smoking or alcoholic beverages are allowed in the facility!

2. The set-up time for table holders will be on Friday, Sept 25<sup>th</sup> from 12 PM to 7 PM and on Saturday morning, Sept. 26<sup>th</sup> from 8 AM to 10 AM. Sunday's set-up time will be from 8 AM to 9 AM. Participants with badges will only be allowed in the hall during these times. All dealers must remain open until 7 PM on Friday to accommodate the VIP pass holders.

3. The show will be open to the public as follows:

Saturday, Sept. 26th, 2020 / 10:00 AM - 5:00 PM

Sunday, Sept. 27<sup>th</sup>, 2020 / 9:00 AM - 2:00 PM

4. Only Civil War or earlier military memorabilia and relics are to be exhibited, or offered for sale or trade. GAR and UCV items that are labeled and offered as such are allowable. The Show Committee reserves the right to have any objectionable material removed from the tables – their word is final! The following is a partial list of objectionable material:

- a. Post-1865 conversions of any Civil War weapons, including, but not limited to Sharps, Colt, 45/70 Springfields, or any cartridge revolvers
- b. Late 1860s field and staff officers, naval officer's lodge or fraternal swords
- c. Post-1865 converted leather goods, canteens, accoutrements, etc.
- d. Post-Civil War uniforms except GAR and UCV that are labeled and offered as such.

5. No reproduction, replica or fake items or artifacts will be allowed for sale: no flea market items of any kind will be allowed. There will be members of the show committee circulating throughout the show who will be responsible for enforcing these rules. The penalty for violating any of these rules and regulations is expulsion from the show and forfeiture of fees for the table(s). Improper behavior on the part of any show participant will result in expulsion from the show.

6. All tables are eight feet long.

7. All tables must be set up by 9:00 AM on Saturday, or they revert to the GBPA. Tables are nontransferable.

8. Security will be provided during hours when the show is not open to the public. However, it is the responsibility of all dealers and exhibitors to provide security over the items on their tables. The Eisenhower Inn and All Star Complex, Gettysburg Travel Council, show promoters and the GBPA assume no responsibility for any loss, theft or injury occurring during the show.

9. Exhibitors must provide covers for their tables.

10. All table holders (sales) must have a Pennsylvania Sales Tax License or Transient Vendors License. Table holders are responsible for collecting and remitting the 6% PA Sales Tax. Note: Our promoter license number is 93-00170-2. Applications can be obtained by writing:

14. Should you not want to have the public photograph any of your items, it is your responsibility to clearly post an 8 ½" x 11" sign stating "No Photography Allowed".

15. The loading sections on the side and rear of the building are to remain clear of vehicles at all times. No Parking in these corridors with the overhead doors.
